- To inform and shape the development of UK100's wider engagement programme with Parliamentarians.
- Support the Parliamentary Officer in building relationships with MPs representing constituencies, particularly in politically significant marginal constituencies often

underrepresented in the climate conversation.

- Provide advice and guidance on major political opportunities and risks to UK100 and our membership.
- Represent UK100 at meetings and public events to promote ambitious action to tackle air pollution and the Climate Emergency from Local Authorities, national Government and business.
- To support and comply with UK100's guidance on branding, tone of voice and key messages, positively contributing towards raising UK100's profile.
