Introduction by UK100 Chief Executive Christopher Hammond

Climate politics and climate action in the UK is at a critical juncture.

The UK is falling behind on its net zero targets, with only a third of the emissions reductions needed to meet

the 2030 target covered by credible plans. WWe have a new Government committed to ambitious climate action, but structual changes and poor policy implementation is feeding a misinformation backlash that threatens progress.

With 80% of the UK's carbon emissions falling within the influence of local authorities, we believe the best solution to delivering net zero nationally, is to look locally. The very existence of UK100 is testament to the ambition of local government to rise to this challenge and opportunity. Our members know that a place-based, just transition, led by those who know their communities best, is most likely to succeed. That's why I am immensely proud of the progress made, however, with 2030

targetsfast approaching, the focus on delivery grows stronger.

Against a backdrop of global uncertainty, UK100 will defend the need for climate action and support its delivery across the UK. Through our membership, we will provide opportunities for innovation, knowledge sharing, networking, and convene members to contribute to our influential research and advocacy campaigns.

By tapping into the collective insights of our network, we will continue to push for the powers all councils need to deliver their targets. In 2025, this will be more important

than ever and we invite you to join us on this journey."

Introduction to UK100

WHY UK100

UK100 is the UK's only cross-party network of local leaders and their councils committed to ambitious net zero targets ahead of the Government's national target.

Member councils gain access to three programmes of support to aid them on this journey. Our membership programme encourages knowledge sharing and collaboration through a programme of events, training and direct support.

Our research and insights work provides members with opportunities to capture local experience and feed into the development of research and delivery toolkits, alongside sector experts. These insights are then used to advocate for the critical role of local leadership in delivering net zero. Collectively, this work fosters dialogue nationally and regionally, and helps to advocate for a just transition across our local communities. In doing so we showcase the determination, capacity and capability of local government in achieving net zero.

HISTORY OF UK100

UK100 was founded in 2016 by Polly Billington (now the MP for East Thanet) to unite ambitious local authorities in the UK to tackle the climate crisis collectively. The idea for the network first emerged when days before the UN Climate Conference in Paris, COP21, dozens of UK council leaders came together and pledged to shift to 100% clean energy by 2050. With this, the first UK100 pledge, from which our name is derived, was born.

Since then UK100 has established itself as the leading cross-party network supporting local climate action, through; sharing best practices, encouraging ambitious action, and advocating for greater powers and financing to achieve net zero. Since our creation, 300 local authorities have declared climate emergencies and the UK parliament passed legislation to bring all greenhouse gas emissions to net zero by 2050.

With an updated net zero pledge in 2021, UK100 now has 116 members and has become a leading voice for local climate action, advocating for greater powers across local government to unlock change.



Goals for the future

UK100 is a member-driven organisation and has always sought input from, and to represent, its members in our advocacy and research work. In 2024, over 50 members contributed to our 'Local Net Zero 2.0: The Moment to Deliver' report which presents an overview of the powers local authorities need to drive the energy transition and housing transformation required for net zero. The key recommendations from this report are a blueprint for devolution:

Local government reform led by local leaders: Transform the settlement with local authorities, including multi-year place-based funding and a statutory climate duty with appropriate resources, clear powers and accountability mechanisms.

2 Joined-up climate devolution: Ensure climate action and devolution are integrated priorities across all government departments, with clear frameworks for


coordination between national and local delivery.

Transform local planning and buildings: Reform planning policy and building standards to prioritise net zero, while reforming social housing retrofit funding to enable truly place based solutions and catalyse wider market transformation and skills development.

4 Local leadership in clean energy infrastructure: Empower local authorities to lead the clean energy transition through strategic energy planning powers including LAEPs, ensure funding for municipal and community energy, meaningful community engagement, and removal of barriers to renewable energy and grid expansion.

5 A new partnership on skills: Work to ensure that Skills England will prioritise the development of net zero construction and retrofit skills, working with local authorities to unlock delivery and green growth.

We will be working with our members across 2025 to explore further opportunities to weave transport- and nature-based powers and funding into our devolution advocacy and practical tools for our members.



Our Support Package

1. We empower bold climate leaders

WHAT LOCAL AUTHORITIES NEED

Members want to know what to prioritise on their climate journey, where they can gather ideas and inspiration, and who they can collaborate and connect with to help them become confident and empowered local leaders ready to drive forward this agenda at pace.

WHAT WE OFFER

A host of innovative projects, programmes and events to support climate leadership, knowledge sharing and collaboration at the local level.

■ **Training:** The <u>Climate Leadership Academy</u> is our one-stop shop for ambitious councillors in leadership positions. Each year, 20 councillors take part in three residential training weekends,

and personalised coaching sessions to develop the political skills, knowledge and confidence they need to drive local climate action. Our **lunchtime learning webinar series** brings policy experts, businesses and councils together to showcase the latest net zero ideas and lessons learnt from across the UK.

Hub we provide real-life examples showcasing the practical realities of delivering different types of interventions. Our political toolkits guide councillors and officers through complex net zero topics such as energy, misinformation and influencing. And our online library provides policy briefings, best practice case studies, and videos, which are all shared in our monthly newsletter.

2. We break down national climate barriers

WHAT LOCAL AUTHORITIES NEED

Members need greater local powers to support the delivery of local climate action and their net zero targets, with our research highlighting their calls for a consistent policy framework, long-term climate investment, and improved national-local collaboration.

WHAT WE OFFER

We use the insights and experiences of our members to demonstrate the collective ambition, commitment and ability of democratically elected local leaders to deliver net zero through innovative thought leadership, cutting-edge communications and platforming our leaders to galvanise the sector.

Member-led research: Each year we undertake member-led research projects to both share best practice amongst our network, in the form of toolkits and briefings, and generate insights, evidence and recommendations to support our case for local climate powers. In 2025, our new Policy

Advisory Group will help shape this work with us.

Member-led advocacy: We use this research to amplify the voices of local leaders via collective advocacy to national government. We convene our members, national politicians and senior officials across Whitehall, at events such as our Clean Energy Superpower summit, we highlight local climate action in national media, and feed members insights and experiences into consultation responses and parliamentary

and parliamentary inquiries.

- **1:1 guidance:** Members can access an annual meeting with our senior team to seek advice on the political barriers hindering their progress.
- Tailored support: With support from trusts and foundations, we offer timebound projects such as Local Power in Action and Local Climate Engagement to provide bespoke

LOCAL POWER IN ACTION

Keen to put their climate leadership skills to the test, the council successfully applied to UK100's Local Power in Action programme in 2023. Through which they were supported to develop the UK's first 'influencing strategy' in partnership with their own Climate Action Partnership. Recognising they cannot do this work alone, this coproduced strategy identified their climate priorities, and who they need to influence locally, regionally, and nationally, to affect change.

Membership pledge

We pledge to lead the UK's climate response by achieving net zero ahead of government targets, using our influence to accelerate ambitious local action, reducing emissions at their source, and collaborating with communities to deliver a fair and just transition...'

In order to access our member benefits and become members, councils must sign our Net Zero Pledge.

Signing the pledge demonstrates the ambition of democratically elected local leaders to do everything within their power to deliver net zero and commits the council to work towards the following:

We recognise that local authorities do not currently have all the powers they need to reach their ambitious net zero targets. For this reason the pledge intends to drive accountability, in the absence of a statutory duty for local authorities to reduce emissions. We will continue to do all we can to support investment and policy changes which will enable you to do what you need to meet your net zero target.





Type & tier


